Each time you connect you are limited to a 1 to 2 hour session depending on a demand/availability formula determined by Mich-Net. Once the system logs you off, you can call right back in again. This benefits most users who dial in for reasonable periods of time, and discourages users who would dial up and stay on the system all day. This is a shared modem pool. We have dedicated lines available for those who want to have their own unshared modem.

A1Access Terms and Conditions

(1) A1access exercises no control whatsoever over the content of the information passing through A1access. A1access makes no warranties of any kind, whether expressed or implied, for the service it is providing. A1access also disclaims any warranty of merchantability or fitness for a particular purpose. A1access will not be responsible for any damage you suffer. This includes loss of data resulting from delays, nondeliveries, misdeliveries, or service interruptions caused by its own negligence or your errors or omissions. Use of any information obtained via A1access is at your own risk. A1access specifically denies any responsibility for the accuracy or quality of information obtained through its services.

(2) A1access may only be used for lawful purposes. Transmission of any material in violation of any US or state regulation is prohibited. This includes, but is not limited to: copyrighted material, material legally judged to be threatening or obscene, or material protected by trade secret. You agree to indemnify and hold harmless A1access from any claims resulting from your use of the service which damages you or another party.

(3) Any access to other networks connected to A1access must comply with the rules appropriate for that other network. Use of A1access itself may be for any lawful purpose. Use of A1access for lawful commercial purposes is both permitted and encouraged. Connectivity is provided for your organization only. Resale or use of the connection by another organization is prohibited.

(4) Service is billed the first week of the month for the current month for credit card users only. Payment is charged to your credit card. The statement on your charge card is your only receipt of the monthly charge. Billing is done in advance. Service is terminated immediately if payment is not collected successfully. Such interruption does not relieve you of the obligation to pay the monthly charge. Only a written request to terminate your service relieves you of your obligation to pay the monthly account charge. Accounts in default are subject to a late payment charge of \$50 and interest charge of 1.5% per month on the outstanding balance. If your state law does not allow an interest rate of 1.5% per month, the maximum allowable rate for your state will be charged. If you default, you agree to pay A1access its reasonable expenses, including attorney and collection agency fees, incurred in enforcing its rights under these Terms and Conditions. If you would like to re-activate there will be a \$15.00 re-activation fee.

(5) After the initial one month commitment, service may be canceled in writing at any time with no penalty. Prices are for delivery FOB Lansing, MI. A1access reserves the right to change the rates by notifying you 30 days in advance of the effective date of the change.

(6) 150 hours of local access per month applies only to the local access numbers.

(7) A1access will include 15 minutes of free telephone support with each new account, after that, support will be billed at \$15.00 per 15 minute segments.

(8) These Terms and Conditions supersede all previous representations, understandings or agreements and shall prevail notwithstanding any variance with terms and conditions of any order submitted. Use of A1access constitutes acceptance of these Terms and Conditions.

(9) A1access.net is not responsible for any long distance charges incurred. The customer must verify that the access number is local by calling your telephone provider.
